5. That this permission does not confer any right on the society for claiming recognition.
6. That the permission is accorded Silver Oaks Educational Society, Seethammadhaara, Visakhapatnam Regd.No.740 of 2016 Dated 31.03.2009 and no other society or body can open a school on their behalf of.
7. The permission is accorded to open the school premises in the locality and there shall not be change in the premises or locality.
8. The society shall provide the necessary material even if it costs more than the deposit amount.
9. Proper and adequate parking area for vehicles shall be provided transporting the children to and for the school.
10. Proper and adequate sanitation facility shall be provided for students especially for girl students.
11. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.

13. The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
14. The school shall have first aid kit and the teachers shall be trained in first aid.

16. The management should submit the list of Laboratory Equipment at the time of Recognition
17. The Correspondent is hereby directed to submit the Renewal of Fire NOC for occupancy of Fire Service Department before applying for Provisional Recognition.
18. The management is hereby informed that, the permission is being given purely on a temporary basis and is subject to the report of State Level Inspection and Vigilance Committee fulfilling of all the prerequisite conditions under A.P. Educational Act, 1982 and it later found that the school has not fulfilled any prerequisites as stipulated, the permission now being given is liable to be withdrawn at once.
