SPECIFIC CONDITIONS:

- 1 The vehicle should be used exclusively for the above said purpose only.
- 2 The driver of the vehicle should carry all valid documents
- 3 While transporting the Students, College/School Staff they should take adequate safety Precautions.
- 4 The driver of the vehicle should not be drunk and drive
- 5 Should not ply on Prohibited roads.
- 6 Should not cause obstructions to the free flow of traffic.
- 7 The above vehicle should not be permitted on PVNR Express Highway at any time.
- 8 The vehicle driver should follow traffic rules.
- 9 The vehicles are not permitted to ply for long Distances during this timings

GENERAL CONDITIONS:

- 1 The permission is valid in the Cyberabad city limits only and while plying in city the buses should not be used for other purpose.
- 2 The buses should not pick up the passengers at different places except from the starting point and stop on the main roads.
- 3 The bus should not be Park on the carriage way in all the arterial roads.
- 4 The buses should ply exclusively for the purpose mentioned with adequate safety.
- 5 They should follow all instructions issued by the traffic officer on the duty from time to time.
- 6 They should not ply on prohibited routes.
- 7 Carrying over dimensional material which hinders the general traffic is not allowed.
- 8 The driver of the bus must carry this permit with him and show it to the officer on duty on demand.
- 9 They should carry a card for recording violation made by the bus driver.
- 10 The bus operators will keep the bus in proper condition and fitness and fitness certificate should be produced when demanded by police officers.
- 11 If there is continuous violation of MV Act or permit conditions during the permit period, if the plying of the buses causes traffic congestion on the above mentioned route, during the permitted hours the permit is liable to be cancelled.
- 12 In addition to the above conditions any other restrictions that may be imposed in future has to be adhered to.
- 13 The buses should not cause obstruction to free flow of traffic.
- 14 In case of any violation of the above conditions the vehicle will be seized and produced before the RTA
- 15 The Board of company should be displayed on the vehicle.
- 16 None of the vehicles should be parked on public road and they should stick on the garage during night. They should carry the entire relevant document like RC, CC, PUC, Insurance, tax permit and fitness certificate when asked by the duty officers while checking.
17. This permission is only from Traffic Police. Necessary permission/NOC/Authorization as required from other concerned authorities has to be mandatorily obtained.
